CADP Overview

Project Objectives: strengthen the management and facilitate value addition in targeted value chains under Nigeria's Agriculture Transformation Agenda (ATA).

Project Description:

Component 1- Value Chain Organization and Management: establishment of marketing corporations; technology, mechanization, storage and processing facilities for small and medium sized commercial farmers; and value chain management, coordination, capacity building and training to improve job opportunities for youth and women.

Component 2- Facilitation of Value Addition in Targeted Value Chains: support for primary processing, markets, farm access roads, technical studies for the rehabilitation of irrigation facilities and aggregation centers.

Component 3- Project Management, Monitoring & Evaluation, Strategic Communication and Studies: establishment of results-based monitoring and evaluation system; impact evaluation and beneficiary assessment; monitoring implementation of safeguard documents; technical assistance and training to develop capacity; and studies to document ATA impact.

<u>**Rice</u>:** Seed Multiplication/Production, Processing, De-stoning Technology, Milling Technology, Parboiling Technology, Packaging and Branding.</u>

Dairy: Artificial Inseminations, Milking Technology, Milking Processing, Packaging, Branding and Quality Control.

<u>**Tree Fruit</u>**: Seedling Multiplication/Production, Processing, Juice Production and Packaging, Quality Control and Branding.</u> **Oil Palm:** Seed Multiplication/Production, Processing, Palm and Kernel Oil Extraction, Processing, Packaging, Branding and Quality Control.

Implementation of Safeguard Policies (actual)

OP 4.01:

- An Environmental and Social Management Framework (ESMF) was prepared prior to appraisal, as the specific project locations had not yet been identified.
- EA Category B at appraisal, as no significant adverse long-term impacts were anticipated or identified in the ESMF.
- E&S risks and impacts identified in ESMF were related to: road rehabilitation, agribusiness, agricultural development and commercialization, land preparation/clearing, and cumulative impacts.
- Safeguard instruments prepared for sub-projects during implementation: (i) Environmental and Social Management Plan (ESMP) for Maize Production; (ii) ESMP for Fruit Juice Production and Packaging; (iii) ESMP for Improved Poultry; (iv) Environmental and Social Impact Assessment (ESIA) for Araga Farm Settlement, Poka/Epe; (v) ESIA for Araga Farm Settlement, Iba; (vi) ESIA for Ikorodu Fish Farm Estate; (vii) ESIA for Rice Processing Centre; and (viii) ESMP for Oil Palm Extraction Technology.
- Project restructuring anticipated no additional E&S risks and impacts beyond what was identified in the ESMF.

OP 4.09:

- Triggered due identification in ESMF of potential pesticide use resulting from agricultural activities.
- A Pest Management Plan (PMP) was prepared prior to appraisal.

OP 4.12:

- Triggered Component 2 includes rehabilitation and/or construction of rural access roads that might result in land acquisition, particularly with regard to potential realignment, borrow pits and construction camps.
- Resettlement Policy Framework (RPF) was prepared prior to appraisal because specific sites where land acquisition may occur had not been identified.
