# Methodology

- Comparison of current safeguard policies as applied to existing projects with provisions of proposed Framework
- Incremental changes to the scope of work for Bank and Borrowers are specified as below:

NO CHANGE	Standard <b>not applicable or no change</b> compared to application of current safeguards
LOW	Minor modifications and additional analytical work needed to address ES Framework requirements
MODERATE	Additional work needed to improve scope, depth and quality of assessment
SUBSTANTIAL	ES Framework requirements not addressed through current approach, but level of incremental efforts not significant
HIGH	ES Framework requirements <b>significantly different</b> in scope and technical depth

### Yunnan Urban Environmental Project

#### **Project facts**

- Objectives: Assist Yunnan Province improving effectiveness of lake basin management in Er'Hai and Dianchi, and to improve effectiveness and coverage of critical urban environmental infrastructure for the development of country towns through expansion and establishment of wastewater services and solid waste management systems
- Financing (US\$): 150M
- Environmental Category: A
- **Safeguards Triggered:** Environmental Assessment (OP4.01), Natural Habitats (OP4.04), Physical Cultural Resources (OP4.11), Indigenous Peoples (OP4.10), Involuntary Resettlement (OP4.12), Safety of Dams (OP4.37)
- Safeguards Instruments : Environmental Management Framework (EMF) ?
- Approved: 2008

- **Objectives**: To achieve compact, transit-oriented development in Kunming by supporting the development of high quality, integrated public transport on the east-west line 3 corridor
- Financing (US\$): 1,453M
- Environmental Category: A
- **Safeguards Triggered:** Environmental Assessment (OP4.01), Physical Cultural Resources (OP4.11), Involuntary Resettlement (OP4.12)
- Safeguards Instruments : Environmental Management Framework (EMF)?
- Approved: 2011
