

# World Bank Group Strategy for Fragility, Conflict and Violence (FCV) Consultation Meeting with Netherlands Government Representatives

# **Feedback Summary**

Date: June 12, 2019

Location: Ministry of Foreign Affairs, the Hague, the Netherlands

Audience: Government Representatives.

**Overview:** Mr. Gert Kampman, Deputy Director Stabilisation and Humanitarian Aid Dept welcomed participants, provided opening remarks, and moderated the meeting. Mr. Franck Bousquet, Sr. Director of the World Bank's FCV Group, presented the main features of the World Bank Group FCV Strategy Concept Note. Participants were then invited to ask questions and share their views. The summary below captures the key points, recommendations, comments and feedback raised during the meeting.

## **Specific Feedback from Stakeholders**

#### 1. Overall

- Participants expressed broad support and endorsement of the strategic directions and areas of engagement outlined in the concept note.
- Concept Note aligns well with the Ministry of Foreign Affairs' approach to preventing confict and addressing the root causes of instability as articulated in its aid policy (May 2018).

#### 2. Partnerships

- Participants noted expectation that the strategy would operationalize some of the recommendations from the (well-received) joint WBG-UN *Pathways to Peace* study.
- Partnership with UN organizations at the country level, particularly on the prevention agenda, is
  essential. Participants questioned what incentives or behavioral changes need to happen within
  the WBG and UN for more systematic joint engagement.
- It was noted that UN organizations are generally ready to implement in FCS more rapidly than the WBG which requires up-front analytical work. Important to acknowledge comparative strengths and flexibilities of each institution to support efficient role out of joint programs. The WBG's convening power and engagement with Finance Ministries can be used to advantage.
- Need to engage systematically with all bilateral actors in FCS (growing role of China in FCS was noted).
- Recommended that the strategy includes support for the role of civil society as a driver of stability.

# **Specific Feedback from Stakeholders**

# 3. Programming

- Participants recognized the importance of designing FCV-sensitive strategies and projects but underlined that working in a 'conflict-sensitive' manner comes down to implementation and dealing with complexities on the ground. Not clear that WB operations across sectors are currently conflictsensitive (i.e Ebola response in DRC). How will the strategy enable staff to work differently in conflict settings without hindering implementation?
- Interventions should not only 'do no harm' but should also promote peace and stability. Likewise, in working with the private sector, how will mobilizing more conflict-sensitive private sector support be institutionalized across the WBG?
- The people-centered approach is highly welcome. The strategy will need to balance focus on citizens while also supporting capacity building of government institutions. Experience has demonstrated that moving away from supporting state actors in conflict situations (i.e Mali) is not a solution. Rebuilding of state capacity and support for communities needs to happen in parallel.
- How will the strategy prioritize WBG financing instruments in FCS will criteria be elaborated? Participants noted that the IDA Crisis Response Window was seen as effective for early action.

#### 4. Monitoring and Evaluation

- Participants suggested that the cooperation with the UN should also extend to M&E, and called for increased efforts on data harmonization, development of joint knowledge management system (need to push boundaries in this area).
- Participants noted support for M&E systems that enable an adaptive 'learning loop' and ability to
  course correct during implentatation as outlined in the Concept Note, but underlined that the
  challenges putting such a system into practice should not be underestimated.

## 5. Personnel

- Strong support for increased decentralization of staff working on FCV and encouragement to be ambitious on this front. Strategy should include not only quantitative but qualitative measures to ensure staff with right experience and expertise on the ground. This will require right package of incentives.
- Increased staff presence will also support greater cooperation between Humanitarian and Development actors.

## 6. Limitations

- Participants encouraged the WBG to be ambitious on the risk component of the strategy. Accept
  limitations of relying on evidence-based driven programming, which may not be available or
  applicable to conflict settings. May require letting go of traditional ways of working, including
  greater reliance on CSOs for implementation.
- Participants recognized that the strategy will be developed within the confines of the World Bank's
  mandate and cautioned that factors beyond mandate (human rights, weapons proliferation,
  geopolitics, quality of government leadership) heavily influence stability. The also asked what role
  WB can play in security sector reform?
